DATES: 8 September, 2018.

LOCATION: Cascade Shooting Facilities outdoor range. 26520 292nd Ave S.E., Ravensdale, Washington.

RULES: Current NRA rules will govern.

ARMS: Match Rifle (Rule 3.3.(a)(b)(c)(d)(e) or Service Rifle (rule 3.1.(a)(b)(c)(d)).

CATEGORIES: Match Rifle, and Foreign Service Rifle categories will be combined. Service Rifle will have a separate award.

OPEN TO: All High-Power Rifle and CMP competitors. The public is welcome to participate.

ENTRY: Each match is limited to 45 competitors. Match fee is \$22.50 plus NRA fee of \$4.50 plus WSRPA fee of \$3.00 for a total entry fee of \$30. Junior shooters, Match fee is \$7.50 plus NRA fee of \$4.50, plus WSRPA fee of \$3.00 for a total entry fee of \$15. You must be a member in good standing of the WSRPA, or a member of your respective State Associations (proof required) if a non-resident.

TIME: Registration 0800-0900 Firing begins promptly at 0915.

CLASSIFICATION: The NRA classification system will be used. Unclassified competitors will fire in the Master class.

TARGETS: 200 yd SR, 300 yd SR-3, 600 yd MR-1 in good weather, or 200 yd SR, SR-42, and 600 yd MR-1 course for inclement weather.

AWARDS: Trophy and cash awards/ rule of 4. Classes may be combined. Winner, High Junior, High Woman, High Service Rifle. WSRPA EIC points and medals.

PULLING TARGETS: Competitors will pull targets or provide their own puller. Competitors will be held responsible for contracted pullers.

MATCH COURSE

2 sighters + 20 shots for record Standing, 200 yd.	Time: 22 minutes
2 sighters, 200 yd.	Time: 2 minutes
2 strings of 10 shots for record Rapid Fire Sitting, 200 yd.	Time: 60 seconds/string
2 sighters, 300 yd.	Time: 2 minutes
2 strings of 10 shots for record Rapid Fire Prone, 300 yd.	Time: 70 seconds/string
2 sighters + 20 shots for record Prone, 600 yd.	Time: 22 minutes
