### **EVENT FIRING ORDER:**

NRA Regional Championship can be fired either day (if fired both days - Saturday score counts for your Regional Championship aggregate).

Saturday: NRA Regional match, matches 17, 18, 19 & 20. Sunday: NRA Regional match, matches 17, 18, 19 & 20.

Match 17: Washington State EIC Match -

30 rounds NMC (50 & 25 yds)

(a fired match taken from the competiors applicable NMC within the NRA Regional match)

Match 18: NRA Distinguished Revolver Match - Stand alone NMC.

30 rounds NMC (50 & 25 yds) 30 rounds NMC (50 & 25 yds)

Match 19: CMP EIC Match - Stand alone NMC (CMP Rules shall govern). Match 20: CMP .22 EIC Match - Stand alone NMC (CMP Rules shall govern).

30 rounds NMC (50 & 25 yds)

**RULES**: Current NRA Outdoor Precision Pistol Rules shall govern.

**ELIGIBILITY**: NRA membership is not required, but is encouraged.

Juniors shall be 12 years of age or older.

To be eligible for the Washington state EIC match competitors must be members of the WSRPA:

**CLASSIFICATION**: NRA classification system shall apply.

**SQUADDING**: All matches shall be squadded. Older Shooters will be squadded closer to the range access door.

SCORING: Scoring shall be performed by competitors. Score plug use by Match Officials only. All challenges shall be made before the target change. Challenge fee: \$ 2.00 ea (proceeds go to Junior Rifle Team).

AWARDS: Cash awards. Small classes will be combinded.

ENTRY FEE: \$35.00 per competitor. Entry fee - CMP EIC Service Pistol or CMP EIC .22 Rimfire matches are \$15.00 each. NRA Distinguished Revolver EIC Match is \$5.00.

(New shooters may shoot .22 across the course if range space allows. Fee \$30.00)

ENTRIES: Advance entries are requested. Post entries will be accepted until the match begins. Match will be limited to one relay on Saturday & Sunday of 22 shooters each day. Please arrive before 08:45.
