CMP EIC, 22, Service Revolver and NRA-DR match: 3:00PM (multiple relays if necessary)
- Location:** Tacoma Rifle and Revolver

- Directions:** Take the South Jackson Avenue exit from Route 16 towards University Place. Jackson Avenue becomes Bridgeport Way West. Turn right onto Chambers Lane West. Chambers Lane West becomes Chambers Creek road West. The club is about a mile on the right. During matches, push the black button at the gate to gain entry to the range. Call 253-439-8622 on match day, if you need additional directions.
- Lodging/Food:** Camping is allowed at the range, with prior arrangements. There is no food service at the range.
- Eligibility:** This is a Washington State Rifle & Pistol Association sanctioned state championship. WSRPA membership or resident state association (for out-of-state competitors) membership is required. WSRPA membership applications will be available at the match. NRA membership is not required. CMP match eligibility is per CMP competition rules.
- Entry Fees:** 2700 point Governor's-20 Championship:
 - Entire 2700, \$35.00 total, (\$24.11 entry fee + \$2.39 tax + \$5.50 NRA fee + \$3.00 WSRPA fee)
 - Individual 900 stage, \$18.50 total (\$9.10 + \$0.90 tax, + one time \$5.50 NRA and \$3.00 WSRPA)CMP Excellence-in-Competition (EIC) Service, Rimfire-22 and Dist-Service Revolver Match's:
 - \$15.00 CMP fee, EachNRA Distinguished Revolver Match. Note: DR match is no longer included as part of 2700 fees
 - \$5.00 Distinguished Revolver (DR) fee. NOTE: You DO NOT need to shoot 2700 to shoot DR matchWashington State EIC Match
 - Included with 2700
- Entries:** Advance entries are requested. Only 22 (11 EACH DAY, DUE TO COVID-19) shooting position available **PRIORITY WILL BE GIVEN TO THOSE TO RESERVED A SPOT.** Post entries will be accepted until the first relay begins. Awards:

1. Awards for first place will be made if class has 3 competitors. Second place awards will be made in classes having 5 or more entries. There must be three competitors in any class to receive awards; less than three, competitors will compete in the next higher class.
2. Washington State Rifle and Pistol Association (WSRPA) Medals will be awarded to the top two competitors in each class, regardless of the number of competitors in that class.
3. The top 10 Washington state competitors will receive certificates signed by the governor.
